Subject of delivery:

Delivery of 50 kWh energy storage system in a flow battery technology dedicated to operate in KEZO Research Centre in Jabłonna.

For the offer to be taken into account it must arrive at the office of the Purchaser by **30.10.2017 r. until 10:00.**
 - c) Can be submitted in person;
3. Criteria:
- price – 100%
4. Delivery date: **8 months from signing the contract.**
5. Guarantee: The purchaser demands a 12 months guarantee for the delivered items.
6. The opening of the submitted offers is set for **30.10.2017 r. at 10:05** in the HQ of the Purchaser.
7. The price of the offer should include all the costs – taxes, import taxes, customs, transport etc.
8. The Purchaser sets a date for asking questions related to the subject of the call for offers for 26.10.2017 r. till 15:00. The Purchaser without revealing the source of the questions, will answer them publically via the website.
9. In the event of any questions concerning the subject of the Call for offers, which could not be explained by e-mail replies, or the explanation could cause the procedure to be extended in time, the Purchaser may, at the request of the Contractor or through its own initiative, schedule a joint meeting of Contractors interested in participating in the procedure. Such information will be posted on the Purchasers website no later than 27.10.2017 until 15:00. In such a situation, the deadline for the submission of tenders is changed. The contracting party will schedule a joint meeting within 48 hours of the date of submission of applications. In the case of a personal inability to arrive, the Employer shall allow telephone contact, which shall be recorded.
